Atlantic Grupa d.d., Miramarska 23, Zagreb (hereinafter: the Company or the Issuer) hereby announces the disposal of 7,900 shares of the Issuer conducted by Zoran Stanković, a member of Management Board, based on the gift agreement signed 19 May 2026. The said shares, of a total nominal amount of EUR 63,200.00, constitute 0.006% of the Company's share capital or 0.006% of votes at the General Assembly of the Company,

Prior to the said disposal, the member of the Management Board Zoran Stanković owned 37,258 shares of the Company, with a total nominal amount of EUR 298,064.00 which constitute 0.28% of the Company's share capital, i.e., grant 0.28% of votes at the General Assembly of the Company. Following the aforementioned disposal, the member of the Management Board Zoran Stanković owns 29,358 shares of the Company, with a total nominal amount of EUR 234,864.00 which constitute 0.22% of the Company's share capital, i.e., grant 0.22% of votes at the General Assembly of the Company.
